I would love to see increased development into our mental defensive systems. I've seen too many agents taken out by concentrated psionic attacks for me to feel safe in my mind. I would love to have more confidence in our boys in Parapsychological Research, but I've found the field results lacking.



5. Describe your relationship with HQ:

There are no words to describe that feeling, living a life of faith and seeing an ifrit for the first time. I still work on reconciling my faith and my work life.

4. Have you ever lost a fellow agent in the field? If yes, describe the experience, and how you plan to avoid it in the future:

It's a great personal shame of mine, but I was assigned to provide support for [REDACTED]. I got into a heated debate with [REDACTED] about whether mind reading should be categorized as HUMINT or SIGINT. In our debate, we neglected our surveillance and a cryptid got the drop on our field team. I will never allow myself to engage in unprofessional conduct while on duty again.



5. Describe your preferred methods when dealing with local authorities and/or military personnel. How do you avoid detection and engagement?

An old trick I picked up from my days as a missionary, I've found that pretending to be canvassing works wonders for hiding in plain sight. Once people hear the words "do you have a minute to talk about..." you suddenly become invisible.

6. Describe your most recent experience in information gathering (reconnaissance, hacking, subject interrogation, etc):

In my most recent collection operation, I was tasked with conducting an interview using non-coercive methods. In preparing the room prior to the interview, I made sure to acquire a comfortable, moving chair. If I am to serve this organization, and the men and women who give so much to it, I need to be unimpeded by the words "above your clearance". Do you know how many agents I have had see put in the ground? Fifteen. I'd name them all, too, but this isn't the place for such memorials. This is the place where I petition for the training that will prevent me from having to bury another friend. I cannot in good faith ask the agents I support to trust me if I cannot prove to them that I know their situation and I deserve their trust. I deserve this because the Agency deserves my best, and I cannot provide that where I am now.
